# TERMS AND CONDITIONS

1. Membership is open to everyone above the age of 18 years.
2. A once off registration fee of R100 is required.
3. Companies should select a maximum of three industries/ service offerings.
4. Monthly payments are due on the 7th of each month. Failure to make payments will result in services not being provided.
5. If members skip more than 3 months without honouring monthly payments membership will be terminated.
6. Tender alerts will not be sent to members and clients that are not in good standing
7. A R100 reinstatement fee will be charged for members who wish to reinstate their accounts.
8. Members can upgrade/downgrade to any plan should they wish to, at any time.
9. Members should participate in the tender pricing process. This will ensure that clients' pricing aligns with the tender requirements to avoid disqualification.
10. Premium plan tender application form filling service is offered to tender with a maximum of 30 pages. Additional costs will be incurred if tender documents exceed 30 pages. A maximum of 5 tenders will be administered for under the Premium Plan. Additional tenders will be billed accordingly.
11. Tenders that fall within the 80 /20 preference points will be allocated to the premium plan.
12. Platinum plan will accommodate all types and sizes of tenders.

13. Members should indicate to the agency by sending the full tender document to the agency's email address or whats app number if they wish the agency to help them bid, fill the tender form, and apply for tenders.
14. Tender submission services will be provided at an extra transportation/courier fee.
15. Tender briefing session attendance services will be provided at an additional fee.
16. Tender compliance services will be provided at an additional fee.
17. The agency does not submit tenders on the last (final) day. Members should indicate their interests to apply for tender in time.
18. The agency is not involved in any tender award decision making process and does not have any influence in the final results of the tender awarding process.
19. Tender alerts will be submitted electronically to all entities via email and or whats App.
20. Compliance services will be provided by the Amahle Amahle Tender Agency at an additional fee. Kindly please refer to our fee structure.
21. Company profile design is for 4 pages; additional page design will be billed accordingly. Kindly please see our fees for company profile additional pages design fees. There is a 2 week waiting period for company profile designing services.
